**ORDER**

Currently pending before the Court is plaintiffs' Motion for Entry of Judgment (Doc. # 166).

On June 21, 1996, the Court entered default judgment in favor of plaintiffs and against defendant. On December 11, 2001, United States Magistrate Sarah W. Hays entered a final report and recommendation to award damages to the individual plaintiffs and members of the certified class. On June 4, 2002, the Court adopted the Magistrate's Report and Recommendation stating that "the award of damages as outlined in the final report and recommendation is granted." On September 30, 2003, the Court issued an Order awarding plaintiff's attorney fees and costs in the amount of \$199,104.00. A Judgment was entered on the attorney's fees and costs award on October 7, 2003. This Judgment is currently on appeal to the Eighth Circuit. Plaintiffs state however, that the Court did not enter an actual judgment on the issue of actual

damages.

Therefore, for good cause shown and with no opposition indicated, plaintiff's Motion For Entry of Judgment is hereby **GRANTED**. The Clerk of the Court is hereby directed to Enter Judgment on the actual damages as reflected in the December 11, 2001 Final Report and Recommendation.
